The owner/developer (Mark Savage) has sought advice from a QC, whose stated opinion is that he has in fact complied with the conditions of the planning permission granted by GBC.

After considerable discussion it was decided that ECPC should contact the owner/developer Mark Savage and ask for an informal meeting with him. Cathy was very opposed to any such meeting being held before the outcome of the Appeal, and so it was decided to contact Mark Savage to discuss a meeting to be held after the Appeal outcome is known.
